There is still a high number of requests for appointments for our consulting.




Head of department for data protection

Working meeting





Beschreibung und Zielsetzungen von der Stiftung für Ehrenamt und Engagement

3.2 Beschreibung des Vorhabens

Der Refugee Law Clinic Siegen e.V. ist eine studentische Rechtsberatung, die sich den Anliegen von Geflüchteten und Hilfesuchenden annimmt. Aufgrund der aktuellen Lage wurde die RLC Siegen mit zahlreichen Herausforderungen konfrontiert. Dies spiegelt sich unter anderem in der Beratungstätigkeit wider, bei der die übliche Beratung in den Räumlichkeiten der RLC in Siegen nicht stattfinden durfte. Weiterhin waren regelmäßige Treffen der verschiedenen Ressorts, der Mitglieder und des Vorstands nicht möglich. Zudem konnte die regelmäßige Supervision mit einem Volljuristen, sowie die wöchentliche Vorlesung im Asyl- und Aufenthaltsrecht ebenfalls nicht in Präsenz stattfinden. Die Arbeit des Refugee Law Clinic Siegen e.V. hat sich zunehmend in die digitale Welt verlagert. Aufgrund der anfangs prekären Situation entfesselte die zunehmende Digitalisierung neue Motivation bei den Mitgliedern, die RLC Siegen vernetzte sich bundesweit mit anderen RLCs und steigerte ihre Mitgliederarbeit. Ein großer Nachteil der Digitalisierung sind datenschutzrechtliche Bedenken, da die Mitglieder von ihren Privatgeräten arbeiten. Weiterhin mangelt es einigen Mitgliedern an der nötigen technischen Infrastruktur. Die RLC Siegen beabsichtigt im Falle einer Förderung insgesamt zehn Laptops für ihre Mitglieder anzuschaffen.

3.3 Ziele/Zielwerte

Zielsetzung der neuen Endgeräte ist es vor. Allem den Mitgliedern der RLC Siegen zu ermöglichen weiter ihrer Arbeiten nachgehen zu können, Hierdurch profitieren die Geflüchteten Mandant*innen der RLC Siegen. Zugleich sollen die an geschaffenen Geräten nur im Kontext der RLC Arbeit genutzt werden, damit datenschutzrechtliche Anforderungen erfüllt werden können.
