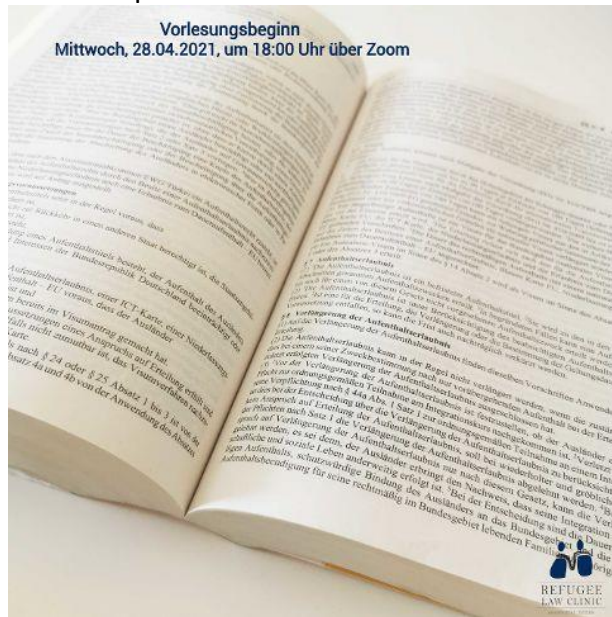
Handover of the departmental management

Together with Ms. Dammeyer from the women's counselling centre for victims of human trafficking "Nadeschda", we dealt with the particular vulnerability of people on the run. In addition, certain factors (e.g. gaps in the support system, lack of information about one's own legal situation, etc.) that can lead to an increase in risk were discussed. The event was attended by 30 participants.


Event „Asylum Seekers Benefits Act“
